### 2. QUALITATIVE AND QUANTITATIVE COMPOSITION

# 3. PHARMACEUTICAL FORM

Cherry-brown coloured, oval softgel capsules.

# 4. CLINICAL PARTICULARS

#### 4.1 Therapeutic indications

DIS-CHEM GOLD HAIR, SKIN & NAILS contains a combination of vitamins and minerals which contribute to the maintenance of normal hair, skin and nails.

### 4.2 Posology and method of administration

Adults 18 years and older: one (1) softgel capsule daily.

Consult a healthcare practitioner prior to use for individuals under the age of 18 years.

#### 4.3 Contraindications

Hypersensitivity to any of the active substances or to any of the excipients listed in section 6.1.

#### 4.4 Special warnings and precautions for use

A healthcare practitioner must be consulted prior to using DIS-CHEM GOLD HAIR, SKIN & NAILS, especially in the case where the patient has a medical condition.

# 4.5 Interaction with other medicines and other forms of interaction

Patients who are taking other medication, including complementary or traditional medicines), should consult a healthcare practitioner prior to use.

#### 4.6 Fertility, pregnancy and lactation

Patients who are pregnant or breastfeeding, think they may be pregnant or are planning to have a baby should consult a healthcare practitioner prior to using DIS-CHEM GOLD HAIR, SKIN & NAILS.
